I have turned 13 years of age before the first day of the state pageant and I will not turn 18 years of age before July 31st, 2018. I attest that I have not entered my senior year of high school. 1. I understand that the director of Miss Smiths Station must approve any appearances made in the name of Miss Smiths Station's Outstanding Teen.
2. I understand that my Miss Alabama's Outstanding Teen competition wardrobe and talent needs to be approved by the Miss Smiths Station staff 2 months prior to the Miss Alabama's Outstanding Teen pageant. I know that this is done to help me be the most prepared that I can be for the Miss Alabama competition.
3. I understand that I must attend Miss Alabama's Outstanding Teen's Contestant orientation. The Miss Alabama's Outstanding Teen Board will set the date for the spring.
4. I understand that my scholarship will be awarded to me after I have completed my competition at Miss Alabama's Outstanding Teen pageant.
5. I understand if I am selected as Miss Smiths Station's Outstanding Teen that my conduct must reflect moral standards in order to be an appropriate role model as Miss Smiths Station's Outstanding Teen.
6. I testify that I am a student in good standing with a passing GPA at an Alabama high school.

7. I agree to seek assistance and coaching from only the Miss Smiths Station staff unless the Miss Smiths Station executive director approves another person.
8. I agree to provide my own wardrobe for appearances and all phases of competition in the Miss Alabama's Outstanding Teen Pageant.
9. I will show appreciation and write thank you notes to contracting parties for all appearances and to all sponsors.
10. I will provide my own transportation to and from scheduled appearances, unless the Miss Smiths Station staff has made other arrangements.
11. I will BE PROMPT. There is never an excuse for being late to any engagement. This will not be permitted at any time.
12. I will never take advantage of the hosts' hospitality. I understand that I must never give the impression that I am sick, tired, or bored. I must maintain interest, enthusiasm, and sparkle during the entire appearance.
13. I agree to be present at appearances organized and scheduled by the Miss Smiths Station directors.

**I understand that the Miss Smiths Station Staff will agree to the following terms:**

1. They will confirm all appearances and requirements pertaining thereto.
2. They will forward to Miss Smiths Station's Outstanding Teen an itinerary of each contracted appearance.
3. They will provide time for study, rest, and vacations in regard to the interest of Miss Smiths Station's Outstanding Teen's good health and mental well-being.
4. They will screen all appearance requests and protect against undesirable appearances.
5. They will provide for adequate coaching, rehearsal, etc. for the role of Miss Smiths Station's Outstanding Teen and her participation in the Miss Alabama's Outstanding Teen Pageant.
